

TOWN OF TROY BOARD MEETING

May 9, 2023

The regular Town of Troy board meeting was called to order by chairman, Jeff Lohr, at 7:30 p.m. at the Town of Troy town hall.

The pledge of allegiance was led by chairman, Lohr.

Roll call was taken with the following responding: Jeff Lohr, Brad Anderson, Greg Sprecher, and Mary Zins. Lloyd E. Ballweg arrived later.

It was confirmed that the agenda was properly posted in three locations in the township and mailed to all board members.

Anderson made a motion, seconded by Sprecher, to adopt the agenda as posted. Motion carried 3-0.

Minutes:

Anderson made a motion to approve the April 18, 2023, minutes as presented, seconded by Sprecher. Motion carried 3-0.

Treasurer's Report:

Anderson made a motion approving the accounts payable checks #9334-#9392 and ACH payments totaling \$16,813.44. Motion carried 3-0.

Citizen's Comments:

There were none.

Patrolman's Report:

Anderson stated that the Town of Honey Creek filled the potholes on Block Road with the understanding Troy will reciprocate next year. There have been several responses to the help wanted advertisement, but there is disinterest when told there are no benefits. The clerk was instructed to remove the deadline to apply from the town's web site.

Business Items:

Brian Sprecher submitted documentation to the board supporting his request for a certified survey map (CSM) which would combine Parcels #0018-2000 and a portion of Parcel #0018-00000.

With the recommended approval of the Plan Commission, Anderson made a motion, seconded by Sprecher, to approve said CSM which will increase Lot #1 to 1.39 acres. Motion carried 3-0.

There was discussion regarding the sale of a 2015 Peterbilt truck by the Town of Spring Green. The board felt a bid of between \$120,000 and \$125,000 would be appropriate. Anderson and Sprecher will inspect said truck on Friday, May 19 at 1:00 p.m.

Anderson made a motion, seconded by Sprecher to transfer \$3,150.04 from the contingency ledger account to the accounts in deficit. Motion carried 3-0.

Board Comments:

Ballweg is willing to mow the town's lawn but requested instructions on how to operate the lawn mower.

Scott Construction is stock piling gravel at the town hall until June. In exchange a load of patch will be given to the township.

Anderson and Sprecher will attend the Sauk County Unit meeting at LaValle on Thursday, May 18, at 7:00 p.m.

Anderson made a motion, seconded by Sprecher, to adjourn the meeting. Motion carried 3-0.

Meeting adjourned at 8:00 p.m.
