-He has talked with the State and they are onboard

-Everything will be inside

-Has been processing deer for the past 3 years

-He was misled by the County- they gave him a permit and told him he was good to go.

-He will be State and/or Federally regulated and an inspector will be there every day.

-He is just looking for the direction as to the next steps to take

-He has a meeting with the County this week

-He hasn't decided if he is going to be State or Federally regulated

-Harvesting will be one day a week

-He needs to ask the County for a variance

-He needs the signatures of the 4 nearest neighbors and currently has 1 of the 4

-He needs an acknowledgement letter signed by the Town Board
