

TOWN OF TROY

BOARD MEETING

October 14, 2025

Pursuant to Wisconsin State Statute §19.84, the regular Town of Troy board meeting was called to order by chairman, Brad Anderson, at 7:30 p.m., on Tuesday, October 14, 2025, at the Town of Troy town hall.

The pledge of allegiance was led by chairman, Anderson.

Roll call was taken with the following responding: Brad Anderson, Greg Sprecher, Doug Larsen, Lloyd E. Ballweg, and Mary Zins.

It was confirmed that the amended October agenda was properly posted in three locations in the township and mailed to all board members. Larsen made a motion, seconded by Sprecher, to approve the amended agenda as posted. Motion carried 3-0.

Sprecher made a motion, seconded by Larsen, to approve September 9, 2025, minutes as presented. Motion carried 3-0.

Anderson made a motion, seconded by Sprecher, approving the ACH payments and checks #10065-#10093 totaling \$244,673.59. Motion carried 3-0.

Citizen's Comments:

Mary Siewert stated that she appreciates having the minutes posted on the town's web site and asked if the clerk would send her the missing minutes.

Patrolman's Report:

- a) A boom mower was rented from Riesterer & Schnell, Inc. The township was not charged for the extra hour of usage.
- b) The dirty chips and sand will be delivered on November 3rd.
- c) Sauk County Highway will grind the trees in Schweppe Road's right-of-way the first week in November.

Business Items:

Dick Meier, Trail Manager of the Honey Creek ATV/UTV Club, requested approval of the ATV/UTV ordinance he submitted to the board to replace the town's current ordinance. This document falls in line with the county's requirement, Ordinance Amendment 09-2025. Anderson made a motion, seconded by Larsen, to approve Ordinance 25-01, ATV/UTV Route Ordinance. Motion carried 3-0. Mr. Meier will send a copy of the ordinance to the Sauk County Sheriff's office and DNR.

Simion Liegel and John Chadwick presented supporting documentation for Mr. Liegel's request to construct an accessory building. Mr. Liegel requested permission to construct a structure on Parcel #036-0390-10000. The property in question is in Sec. 16, T4N, R5E. Said outbuilding will be used for storage and will measure 38' x 56'.

With the recommended approval of the Plan Commission, Sprecher made a motion, seconded by Larsen, to approve the erection of a 38' x 56' pole shed provided a land-use permit is obtained from the county and a building permit from the town's building inspector. Motion carried 3-0.

Scott Evenson asked the board to approve a conditional use permit for a home-based business located in the east half of the southwest quarter of Section 17, T9N, R5E. Mr. Evenson indicated that he wishes to expand his deer processing business to include beef and swine. Any slaughtering would be done on the customer's property and processing on Mr. Evenson's.

With the recommended approval of the Plan Commission, Anderson made a motion, seconded by Larsen, to approve the request for a home-based business provided all county and town stipulations are followed. Motion carried 3-0.

The town board and officers will be working on the 2026 budget on Tuesday, October 21st at 7:30 p.m.

DeMars hasn't been able to install the iron curtain system because they are waiting for an electrician.

The Department of Natural Resources is requesting an updated ordinance regarding garbage/recycling. Anderson made a motion, seconded by Larsen, to approve Ordinance #3-25—Recycling/Garbage Ordinance. Motion carried 3-0. A copy of the ordinance will be sent to the DNR.

Michael Maestri notified chairman Anderson that Carisolo, Inc., with the approval of the county, will have a shipping container at their place of business for six months.

The town's new truck is at Burke Trucking and the recently used truck purchased needs to go to K & B for DOT inspection.

Plan Commission chairman, Brian Hanson, forgot to have updating the flow chart issue on their September agenda.

Anderson made a motion, seconded by Sprecher, to transfer \$50,000 from the patrolman's ledger account, \$8,000 from the miscellaneous expenses—buildings ledger account, and the remainder from the money market to cover the ledger accounts in deficit. Motion carried 3-0.

Board Comments:

Troy will be hosting the WTA district meeting on November 20.

Sprecher and Larsen reported on a recent Sauk Fire District meeting.

Larsen attended the WTA convention on Monday, October 13.

Anderson made a motion, seconded by Larsen, to adjourn the meeting. Motion carried 3-0.

Meeting adjourned at 8:25 p.m.
