



TOWN OF TROY BOARD MEETING

November 11, 2025

Pursuant to Wisconsin State Statute §19.84, the regular Town of Troy board meeting was called to order by chairman, Bradley Anderson, at 7:35 p.m., on Tuesday November 11, 2025, at the Town of Troy town hall.

The pledge of allegiance was led by chairman, Anderson.

Roll call was taken with the following responding: Brad Anderson, Greg Sprecher Doug Larsen, Lloyd E. Ballweg, and Mary Zins.

It was confirmed that the agenda was properly posted in three locations in the township and mailed to all board members. Sprecher made a motion, seconded by Larsen to approve the agenda as posted . Motion carried 3-0.

Sprecher made a motion, seconded by Larsen, to approve October 13, 2025, minutes as presented. Motion carried 3-0.

Anderson made a motion, seconded by Sprecher, approving the ACH payments and checks #10094-#10115 totaling \$24,009.29. Motion carried 3-0.

Citizens' Comments:

There were questions concerning the 2026 levy that was passed.

Patrolman's Report:

Patrolman, Dale Yanke reported and requested:

- a) If he could spread the dirt by the old garage and spread grass seed.
- b) Remove broken road pieces by garage and use them as fill for holes in ditches.
- c) Asked the chairman to highlight a map showing which roads he will be responsible for plowing during the winter season.
- d) Needs more road signs ordered.
- e) Several Black Hawk residents are dumping their yard waste on the town's property.

Business Items:

Anderson made a motion, seconded by Sprecher, approving the 2026 budget as presented at the town meeting. Motion carried 3-0.

The Town Board received notification from Land Resources that the county has approved Scott Evenson's request for a home-based business. It was understood that he has received a grant to upgrade the electricity at his facility. The clerk sent documentation

her office received from Land Resources to all board members and the chairman of the Plan Commission.

DeMars Plumbing has installed the iron curtain per the estimate submitted. On a monthly basis salt must be added. As a side note, Country Plumber was called to empty the holding tank.

Sprecher and Anderson picked up the truck the board purchased from the Town of Springfield. The new truck is at Burke Truck waiting for the box and plow.

Sprecher made a motion, seconded by Anderson, to transfer \$2,894.05 from black top/cold mix and \$5,126.12 from patrolman's salary to cover ledger accounts in deficit. Motion carried 3-0.

Board Comments:

On Thursday, November 20, the township of Troy will be hosting the WTA district meeting. There was discussion what food and drinks to furnish and how to arrange the town hall for the meeting.

Correspondence from Cross, Jenks, Mercer, & Maffei was reviewed. Effective January 1, 2026, the attorney fees will be \$245/hr. and paralegals and staff \$150/hr.

Chairman, Anderson, is applying for TRIP funds for the upgrade on Babbington Road.

Sprecher made a motion, seconded by Anderson, to adjourn. Motion carried 3-0.
